1. The Government of Nepal [GoN] has allocated funds towards the cost of **Local Road Bridge Project (LRBP)** and intends to apply part of the funds to cover eligible payments under the Contract stated below. Bidding is open to all eligible Nepalese Bidders.
2. **The Office of District Development Committee, Sindhupalchok** invites sealed bids or electronic bids from eligible bidders for the construction of motorable bridge with contract details as follows.

A complete set of Bidding Documents may be purchased from the office of **District Development Committee, Sindhupalchok** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee as given in the above table till 2073/08/21.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may down load the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np](http://www.bolpatra.gov.np). Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 6. Pre-bid meeting shall be held at **Office of District Development Committee, Sindhupalchok** at **12:00 PM NST 2073/08/10**.
7. Sealed or electronic bids must be submitted to the office of **District Development Committee, Sindhupalchok** by hand/courier or through PPMO website [www.bolpatra.gov.np](http://www.bolpatra.gov.np). on or before **12:00 PM NST** on **2073/08/22**. Bids received after this deadline will be rejected. The bids will be opened in the presence of Bidders' representatives who choose to attend at **1:00 PM NST** on **2073/08/22** at the office of **District Development Committee, Sindhupalchok**.
8. Bids shall be accompanied by a Bid Security in acceptable format, for the amount and validity period as specified in the above table.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission. Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
10. Bidders may withdraw or modify the bid 24 hours before the last date of submission of bid by submitting of sealed application to **DDC Sindhupalchok**.
11. The bidders who submit bid electronically are requested to submit all the original hard copy bid documents within 7th day after bid submission date by post or any other way at **office of DDC Sindhupalchok**. Failure to submit the original hard copy shall be ground for declaring the bid non responsive.
12. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
13. Any matters not covered by this notice shall be as per **Local Body Financial Administration Regulation 2056 (with all amendments)** of GON.
